#### NISGA'A PERMISSIVE EXEMPTIONS REGULATION, 2015

#### **Definitions**

**1.** In this Regulation:

"Act" means the Nisga'a Real Property Tax Act;

"current year tax" means, in relation to a property for a taxation year, the tax that would otherwise be imposed in respect of the property for the taxation year under section 18 of the Act, but does not include arrears, penalties, delinquent taxes or interest on any of them.

## Permissive exemptions

- 2. (1) The lands described in Schedule 1, and any improvements located on those lands, are exempt from current year tax for the 2015 taxation year.
  - (2) The lands described in Schedule 2 are exempt from current year tax for the 2015 taxation year to the extent they are not exempt from that tax under section 8(1)(g) of the Act.
